Start, Finish & Miles are marked with yellow paint. (UP = Utility Pole).

**Start:** On the east side of S Franklin St 1 ft S of Storm Drain on same side & 12 ft 4 inches N of Manhole Cover on S Franklin at NW corner of Elysian Ave & S Franklin.

**Mile 1:** On southeast side of River (Piermont Ave) Rd under eastbound bridge for I-87 20 ft N of the Corner of the 10-foot high metal fence.

**Mile 2:** On the east side of River (Piermont Ave) Rd 10 ft S of south edge of driveway for 191 to 199 River Rd.

**Mile 3:** On west side of Piermont Ave at south edge of Storm Drain across from southern most parking spot for Pier 701 at 701 Piermont.

**Mile 4:** On north side of Ferry Rd 10 ft E of "Speed Limit 15" sign & 24 ft E of UP 101 both on opposite side.

**Mile 5:** On south side of Ferry Rd 54 ft E of Brown & Samuels Memorial Bench on same side & about 110 ft E of UP 1028 61825 7992.

**Mile 6:** In middle of the intersection of Ash St & Piermont Ave at the north edge of the Manhole Cover there.

**Mile 7:** On west side of River Rd (Piermont Ave) 3 ft N of south edge of Driveway for 259 River Rd.

**Mile 8:** On west side of River Rd (Piermont Ave) across from 70 River Rd & 6 ft S of steps for 67 River Rd.

**Mile 9:** On the east side of S Broadway even with the south side of a Storm Drain at the top of the driveway for 453 S Broadway.

**Finish (Mile 10):** Even with the south end of a large boulder near the end of the Raymond G. Esposito Trail (Old Erie Path) just S of Division Ave and the Franklin Street Park, and 13 ft 6 inches S of UP 24 61333 39598 on east side of S Franklin St

**Alternate Finish** from a right turn from Cornelison Ave onto S Broadway to left onto Clinton Ave, to left going S on the Raymond G. Esposito Trail (Old Erie Path) to a Turnaround on the Trail and then following path to the same finish as the original route.

**Alternate Mile 9a:** On the south side (but marked on the north side) of Clinton 120 ft W of S Broadway & 13 ft W of the driveway for a large white house at 192 S Broadway.

**Turnaround (TA):** Middle of the Raymond G. Esposito Trail (Old Erie Path) about 0.37 miles S of Clinton Ave, 83 ft 6 inches S of the concrete steps to the Elizabeth Place Dog Park, Town of Orangetown, and 36 ft S of a double maple tree on east side of trail marked by a spot of yellow paint at its base.
