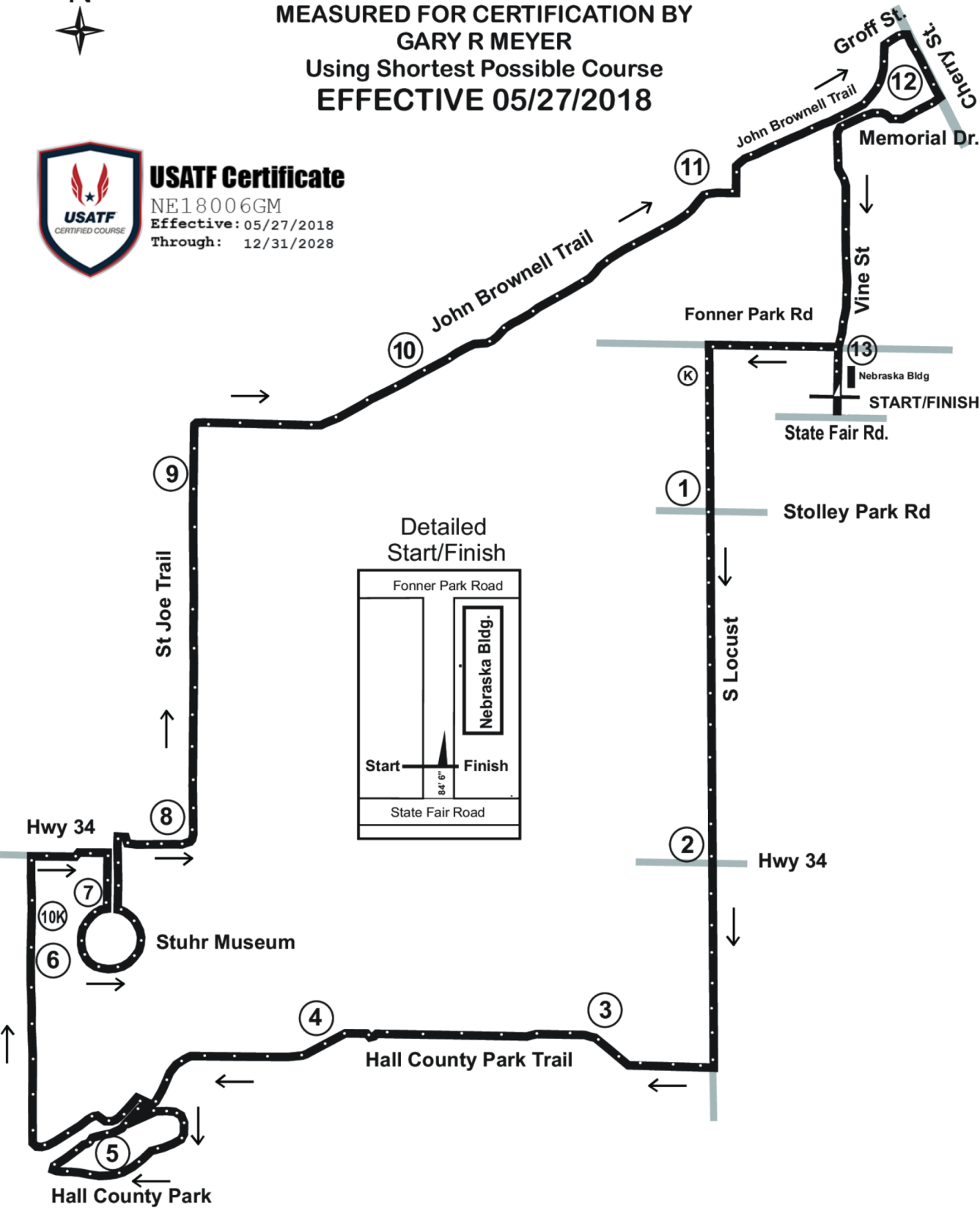

Points Measured Nebraska State Fair Half Marathon

- Start** 84' 6" N of pavement seam at N side of State Fair Road
- K** 3' 6" S of pavement seam to parking lot between Girard and Wyndot on S. Locust
- 1 Mile** 30' N of sewer inlet at NW corner of Stolley Park and S Locust.
- 2 Mile** 53' 6" N of curb cut to large storm drain on NW corner of S Locust at Hwy 34
- 3 Mile** on Trail approx. 3/8 mile W of S Locust. 34' E of high power transmission lines crossing over the trail (gps location N 40 52.796 W 098 20.759)
- 4 Mile** on trail W of Blaine, 76' W of 5th gate cinch on S side of trail near sandpit operation. (N 40 52.757 W 098 21.871)
- 5 Mile** 33' N of speed limit 10mph sign on W side of Clayton Hall County Park, and about 400' N of Tri-City Cycle Works (N 40 52.808 W 098 22.532)
- 6 Mile** 63" S of fire hydrant S of Bike Repair station on trail W of Stuhr. (N 40 52.725 W 098 22.658)
- 10K** 235' S of Bill Board on trail W of Stuhr. (N 40 52.909 W 098 22.665)
- 7 Mile** Entrance road to Stuhr Museum, 73' N of lite pole at head of traffic Circle.
- 8 Mile** On trail just E of Central C.C, find pole #1769 near Wartman and Hwy 34. Mark is 12' SW of that pole
- 9 Mile** 112' N of center trail pole on N side of Stolley Park (next to Shuster Anderson Buick bldg.
- 10 Mile** E of Dan & Mary Alender bench on John Brownell trail and 199' W of gate post S of Harrison and Laura.
- 11 Mile** 9' S of N curb on NW Corner of Pine and Oklahoma
- 12 Mile** 18' S of pole # 1081 at Memorial Dr and Cherry
- 13 Mile** 10' S of 2nd fire hydrant inside E Fonner Park Rd.
